

## Nationally Accredited Training

The accredited Certificate IV and Diploma of TESOL Courses are provided through a collaboration between TESOL Australia and Language Training Institute (LTI).

Delivery and assessment of the course will be facilitated through LTI, RTO Provider No. 30173.

## Entry Requirements

In order for you to gain entry into LTI's TESOL Courses, you need to provide evidence of a sound level of ability in written and spoken English. One of the below examples of evidence of English proficiency must be provided prior to enrollment in the course. The LTI Admissions Team will then assess if you meet the course entry requirements based on the evidence provided.

### Evidence of English proficiency examples include:

Secondary School transcripts showing a pass level or higher at the completion of Australian senior secondary school (Year 12) or a very high level at the completion of junior secondary school (Year 10)

Completion of a Certificate III or higher level Course in the Australian Qualification Framework (this must have been studied / completed in English)

Enrollment in other courses of study requiring equivalent or above levels of English ability (for example a University Bachelor Degree)

A result from an endorsed test of English proficiency (with an IELTS score of 5.5 or equivalent for 10695NAT - Certificate IV in TESOL entry or 6.0 for 10688NAT - Diploma of TESOL entry)

If you are unable to provide evidence of English proficiency, please contact us to discuss what options are available. You may be asked to complete an entry test or participate in an interview over the phone or face to face.

## 10695NAT - Certificate IV in TESOL Entry Requirements

(when using English proficiency tests)

If your evidence of English proficiency is an endorsed test, then 10695NAT - Certificate IV in TESOL (Teaching English to Speakers of Other Languages) entrants should have an English proficiency notionally equivalent to a minimum IELTS score of 5.5. ## 10688NAT - Diploma of TESOL Entry Requirements

If your evidence of English proficiency is an endorsed test, then 10688NAT - Diploma of TESOL (Teaching English to Speakers of Other Languages) entrants should have an English proficiency notionally equivalent to a minimum IELTS score of 6.0. ## Assessment

The course is structured by a series of tasks that address the various aspects of each unit. These tasks will be completed and assessed as you progress through the course. Your

trainer will give you guidance on how to complete the assessment tasks and also provide you with feedback on your assessment tasks throughout the course.

Unless a special exemption applies, all LTi TESOL Course students are required to submit their assessment via the LTi TESOL On-line Student System (TOSS).

The assessment is competency based. This means that you will be graded as 'competent' (C) or 'not yet competent' (NYC). If you are graded NYC you will be given another opportunity for reassessment and will be provided with specific feedback on areas needing improvement. You need to be assessed as competent in all of the assessment tasks in order to be awarded your qualification.

## Practical Placement

As part of the course, you will take part in a practice teaching experience where you observe an experienced trainer teaching English to speakers of other languages and then actually plan and deliver your own English as a Second Language (ESL) lessons. This is so that you can demonstrate that you have the skills required to put the theory of the course into practice. Your teaching will be observed by a qualified ESL teacher who will be able to provide you with **feedback and support to help develop your teaching ability**. At the end of the course, **we want you to feel confident in your ability to teach when you enter an ESL classroom**.

**The 10695NAT Certificate IV in TESOL** comes with a 6 hr teaching observation and a 6 hr teaching practice, to prepare you in your ESL teaching role.

As part of your online theory training, you will have the option of completing the 6 hr teaching observation through guided videos to prepare you for your 6 hr teaching practice.

The 6 hr teaching practice is then completed with 5 or more English as a Second Language learners (International students/migrants) in an in-class setting.

To complete the 6 hr teaching practice you can choose one of the following options:

1. Free: Self-arranged 6 hr teaching practice at an ESL school, TAFE or migrant/community centre observed by a qualified TESOL teacher (support provided in how to find and arrange your own teaching practicum). This may be your own workplace with ESL students or find a school willing to allow you to do the practice teaching free with no charge to TESOLAU. Qualified TESOL teacher - ELICOS standards - degree any field, Cert IV in TESOL or higher TESOL qualification required to supervise.
2. Pay an additional \$250 fee for assessment of your own self-arranged video recorded 6 hr teaching practice (support given in how to set up and conduct the lessons).
3. Pay an additional \$350 fee for an arranged Practicum experience: This fee is payable after completion of your theory units or prior to the start of the Practicum (whichever comes first). This fee covers arrangements made with institutions or supervisors who

make it possible for you to gain access to their time, facilities and students. A very professional addition to your resume which can pay off in the long run when applying for teaching positions.

**The 10688NAT Diploma of TESOL** comes with a 10 hr teaching observation and a 10 hr teaching practice, to prepare you in your ESL teaching role.

As part of your online theory training, you will have the option of completing the 10 hr

teaching observation through guided videos to prepare you for your 10 hr teaching practice.

The 10 hr teaching practice is then completed with 5 or more English as a Second Language learners (International students/migrants) in an in-class setting.

To complete the 10 hr teaching practice you can choose one of the following options:

1. Free: Self-arranged 10 hr teaching practice at an ESL school, TAFE or migrant/community centre observed by a qualified TESOL teacher (support provided in how to find and arrange your own teaching practicum). This may be your own workplace with ESL students or find a school willing to allow you to do the practice teaching free with no cost to TESOLAU. Qualified TESOL teacher - ELICOS standards - degree any field, Cert IV in TESOL or higher TESOL qualification required to supervise.
2. Pay an additional \$350 fee for assessment of your own self-arranged video recorded 10 hr teaching practice (support given in how to set up and conduct the lessons).
3. Pay an additional \$550 fee for an arranged Practicum experience: This fee is payable after completion of your theory units or prior to the start of the Practicum (whichever comes first). (This fee covers arrangements made with institutions or supervisors who make it possible for you to gain access to their time, facilities and students. A very professional addition to your resume which can pay off in the long run when applying for teaching positions.

## Course Outcomes

Please note: The course is assessed holistically and students must complete all assessment for the whole course to be awarded the full qualification, except for Unit 1 - TESCIE001 - Create a culturally inclusive learning culture, and Unit 9 - TESDRF001- Develop Resource Files.

10695NAT - Certificate IV in TESOL (Teaching English to Speakers of Other Languages) = all 9 Core Units and 1 Elective Unit

10688NAT - Diploma of TESOL (Teaching English to Speakers of Other Languages) = 9 Core Units and 5 Specialisation Units

If a student withdraws from the course after completing the theory of the course, but before they have completed all practical placement, then they may be awarded a few units of competency (depending on assessment items completed).

## Certificate IV Course Outcomes

*Below is a basic breakdown of the two possible outcomes for graduates of the 10695NAT - Certificate IV in TESOL (Teaching English to Speakers of Other Languages).*

### **Outcome A**

(for those with no previous teaching experience or qualifications): Participants who do not have the qualifications or experience outlined under Outcome B below will be able to teach English in a less demanding and less professional capacity. For example:

To groups of visiting students on short term study tours

To small groups of migrants in a supervised and limited capacity for the development of general English skills

To overseas students on an individual tuition or small group tutorial basis

Overseas in institutions not governed by Australian standards where predominantly conversational English teaching is required

### **Outcome B**

(for experienced or qualified participants): A participant who already has a Tertiary Level degree and then also completes the Certificate IV in TESOL will find a wider range of employment opportunities.

## Diploma Course Outcomes

*Below is a basic breakdown of the two possible outcomes for graduates of the 10688NAT - Diploma of TESOL (Teaching English to Speakers of Other Languages).*

### **Diploma - Outcome A**

(for those with no previous teaching experience or qualifications):

Graduates who complete the Diploma and do not have any previous qualifications (in any area of training/education) or experience may find employment for the provision of teaching English as a second language in a variety of capacities including the following:

Teaching and/or coordinating English programs to groups of students visiting Australia on short to medium term study or English focus tours

Teaching a variety of English language programs in Australian language schools where a higher education degree is not required

Teaching migrants for the development of general English skills

Developing English language programs for individual or small groups of overseas students on a tutorial basis (to support existing studies, e.g. at University level)

Developing English language programs and/or teaching in overseas institutions not governed by Australian standards

## **Diploma - Outcome B**

(for experienced or qualified participants): In addition to the above outcomes, a graduate who already has a Tertiary Level degree and then also completes the Diploma in TESOL may find employment for the provision of teaching English as a second language in a wider range of capacities including the following:

Developing English language programs, especially in conjunction with teaching, at an Australian or overseas language school

Acting in a supervisory capacity at an Australian language school

Teaching in overseas institutions in higher level positions where a university degree is required or preferred in addition to a TESOL qualification

## **Distance Education**

### **Online / Distance Learning**

Enroll anytime and study from anywhere in the world. Complete the TESOL Certificate IV or Diploma online at your own pace with the support of a qualified distance trainer to guide you through your studies.

Students are provided with around 700 pages of course materials (in print or on-line) especially written for the LT*i* TESOL course. Assessment work is submitted via the LT*i* TESOL On-line Student System (TOSS).

Practice Teaching is a vital part of doing our TESOL Courses and we provide you with a 150 page Practice Teaching Guide which includes all the paperwork you will need to complete your Prac in a meaningful and professional manner. A good prac experience also looks great on your resume and can position you even better to get that job of your dreams. Read below for more information about the Practice Teaching part of doing our Course online and by Distance Education.

### **Course Duration & Study Hours**

There is no set schedule for distance learning and the time it takes a student to complete the Course will depend on such factors as:

- ability to study
- how much time can be given to study each day or week
- English language knowledge and competence
- past experience with any kind of teaching
- motivation to finish the Course quickly
- desire to do extra study and research along the way

- other personal factors including health, family, financial and employment circumstances

In the past, some highly motivated students with excellent reading and writing skills have worked intensively to complete the Certificate IV within 4 to 6 weeks. Other students have worked hard to get it done in 3 to 6 months and still others have taken 6 to 9 months, or a year or two.

Unless otherwise stated in any specific Course information, LTi allows students the following maximum time to complete the Courses:

- Cert IV - up to 2 years
- Diploma - up to 2 and a half years

Students that need more than these maximum time frames must apply for an extension and pay an Extension Fee.

## Full Time vs Part Time

Students can choose to be "Full Time" or "Part Time". However, there is no additional fee for changing from Full Time to Part Time. Also, a Part Time student may finish the Course as quickly as a Full Time student.

Based on the official hours allocated to these **Australian Government accredited courses**, the following times apply. Please note that students may complete the Courses in more or less time due to their ability, motivation and many other considerations (as outlined above):

### **10695NAT - Certificate IV in TESOL (Teaching English to Speakers of Other Languages)**

Full-time: 12 months allowing 12-15 hours per week

Part-time: 24 months allowing 6-8 hours per week

### **10688NAT - Diploma of TESOL (Teaching English to Speakers of Other Languages)**

Full-time: 18 months allowing 15-20 hours per week

Part-time: 30 months allowing 10-12 hours per week



# LTi Payment and Refund Policy

## Course fee

The Course Fee will vary depending on factors such as:

- Distance education or class delivery format
- Location of the course, if the course involves class delivery format
- Special promotional offers

## Course Resources

The Course Fee covers a full TESOL Training Suite which is available online to download. Please note: LTi has a policy of retaining all assessment submitted by students. Therefore, if students have submitted their answers in the Workbooks provided by LTi they will need to return their Workbooks containing the completed assessment to their trainer who will provide them to LTi for record keeping purposes at the end of the course.

## Possible Additional Fees

### Extension Fee

The close of study date varies depending if you chose full-time or part-time. If you are unsure of your close of study date, please contact LTi.

If for any reason an extension is required, you can apply for one by completing a [Extension Application Form](#). Extensions will incur an additional fee which may range from \$250 for 3 months up to the full course fee (depending on circumstances)\*

## Document Reissue Fee

A Document Reissue fee will apply in the event that a student requests the reissue of a Certificate, or Competency Transcript, or Statement of Attainment issued by LTI that they had previously received. The Reissue Fee is \$99\*
